Provisional booking for a function to be held at the Devon Valley Hotel

Thank you for your booking at the Devon Valley Hotel. We will do our utmost to make your function an unequalled success. To assist in the smooth running of the event, we would appreciate you taking the time to fully familiarise yourself with our standard Terms and Conditions listed below.

THESE TERMS AND CONDITIONS ARE APPLICABLE TO ALL FUNCTIONS HELD AT THE DEVON VALLEY HOTEL, AND ARE BINDING ON THE PERSON MAKING THE BOOKING (THE HOST) UPON CONFIRMATION OF THE RESERVATION BY PAYMENT OF THE SPECIFIED DEPOSIT.

1. All provisional bookings will be held only for a maximum of 7 days.

If no deposit to confirm the booking is received within this period, the booking will be cancelled without further notice. To confirm a booking we require a deposit of 50% of the estimated Food and Beverage cost or the total Room Hire, whichever is the greatest.

2. The contract price will be calculated by multiplying the expected number of guests by the charge per head.

The following additional charges may also be applicable and thus form a part of the contract price:

Venue Hire: R8 000

Includes: White or cream freeform tent, fairy lights, name stand, white linen and serviettes, white chair covers, cutlery, crockery and glasses, round or rectangular tables and chairs.

Excludes: Coloured overlays, tiebacks, flowers and any other decorations.

Ceremony Charge: R3 000

Includes: Red/cream carpet, plain white garden chairs, white chair covers, pa system, podium

Excludes: Arch, flowers and any other decorations.

Complimentary Gift: An engraved cake knife and accommodation in a Junior suite including breakfast for the wedding couple.

Menu Options: Please consult our banqueting coordinator for our new menu prices and options.

Accommodation rates for your wedding guests:

Single: R935 per person

Double: R685 per person sharing

The rates above include breakfast and are:

- Subject to availability for a Classic or Cellar room only

- Valid until 31 March 2009
- Net and non – commissionable

3. The balance of the estimated Food and Beverage charges or the total of the Room Hire, which ever is greatest, is payable in full 30 days prior to the function. You will be required to notify the hotel of the anticipated number of guests attending, not less than 14 days prior to the function.

4. The final numbers of the guests attending the function must be given to the Hotel 48 hours prior to the function.

This number may not be amended by more than 10 % of the previously anticipated number. The amount payable by the customer shall be calculated on this final number, unless the number of guests attending is more than the final advised number.

5. The Hotel has an award winning and reasonably priced winelist. Over and above this we produce our own wines from the vineyards surrounding the Hotel, under the SylvanVale label. Fruit juices, Minerals, Spirits, Wines and Beers may never be brought in and must always be purchased from the hotel. We do not offer corkage, except sparkling wine at R30.00 per bottle.

6. The final balance of the amount due, which includes the beverage bill, can only be calculated immediately after the function, and must be settled on the same day or night, unless other arrangements have been made.

7. The function fee includes the use of the venue for a specified time period.

Breakfast functions must end by:	11h30
Brunch functions must end by:	14h00
Lunch functions must end by:	16h00
Dinner functions must end by:	23h45

In the case of Dinner-Dance functions, the Hotel reserves the right to ask the DJ or Band to lower the music volume, should it be loud enough to disturb our other guests. Dance music is limited to 23h30 pm at the latest. Functions that extend past the specified time without prior specific written agreement by the Hotel, will attract a surcharge of R500 per hour or part thereof.

The Hotel reserves the right to strictly limit the duration of the function to the specified time.

8. The Hotel reserves the right to object to the employment by the customer and guests of any person in connection with any function.

9. The Hotel reserves the right to cancel any bookings forthwith and without liability on its part in the event of damage or destruction of the allocated rooms by fire

or cause, any shortage of labour or food supplies, strikes, lockouts or industrial unrest, or any other cause beyond the control of the hotel which shall prevent it from performing its obligations in connection with any booking. In the circumstances every effort will be made to accommodate the booking.

10. The Devon Valley Hotel does not take any responsibility for any of the Guests' or Hosts' belongings (including gifts) or for any injury, damage or loss suffered by any persons, and the Host accordingly indemnifies the Hotel against any and all claims arising out of the loss or damage to any such belongings.

11. The Host is responsible for any loss or damages to the Devon Valley Hotel's property and shall pay the amount due on receipt of a written request. The customer shall not be entitled to assign the booking to any third party nor utilize the Hotel's facilities for any other purposes than that stated in the covering letter without the prior written approval of Louis Group Hotels and Vineyards.

12. The Devon Valley Hotel reserves the right to use the Hotel's other venues for functions on the same day as the Host's function, should space and numbers permit.

13. The Hotel requires an update of your accommodation booking arrangements eight weeks prior to the arrival date. Please advise in writing if the full room allocation is to be maintained or if rooms may be released due to slow uptake on bookings. 30 Days / four weeks prior to arrival a preliminary rooming list in alphabetical order is required as well as a commitment as to how many rooms must be held for this function.

A final rooming list with arrival / departure details must be submitted 14 days prior to the arrival date. Any additional bookings from this date must be confirmed with our reservations office directly. Should any rooms be cancelled between fourteen and seven days prior to arrival date, a cancellation fee of 50 % of the total contracted tariff will apply.

14. If you should cancel the function and we are able to re-book the space, the deposit, less an administrative charge of 1 % of the contracted price, not to exceed R500.00, will be returned to you. However, if we are unable to re-book the space, the deposit less an administrative charge, will be retained by the hotel as liquidated damages.
